Project Preview

With the support of the British Embassy in Tirana, the Institute for Democracy and Mediation (IDM) in partnership with Citizens Channel and the Albanian Institute of Sciences (AIS), will implement the project "*Increasing the responsiveness of the Parliament to citizens' concerns*". This project aims to strengthen the Parliament's efforts to foster an enabling environment for inherent engagement of citizens in the policy and legislative processes in the country, as a means of promoting public interest and building trust in the institution.

Activity Preview

The Training, which will be held in October 2023 in two of the targeted districts, aims to increase the capacities of civil society, allowing them to improve their understanding of the Budgeting process and enable their participation in the Budgeting cycle in the Parliament. The training aims to strengthen comprehension and monitoring skills in regards to the Drafting, Approval and Reporting Process of the State Budget in the Parliament, as well as raise responsiveness and participation capabilities during the phases of Planning and Approval of the State Budget and policies concerning Public Finances. Another aim of the training is to inform about the existing legal instruments who allow for participation, proposals or hearings in the Parliamentary Committees.
